

On or before 12:00 Noon on 2075/03/04. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/03/04 at the Barahathawa Municipality office, Barahathawa, Sarlahi. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.
